#### What is the offer?

#### What is the offer duration?

- \*27<sup>th</sup> August 2022 (00:00 hrs) to 31<sup>st</sup> August 2022 (23:59 hrs).
- \*Please check the product page to check offer applicability.

## What other conditions should apply to avail the offer?

- \* Minimum Transaction Value and Maximum Discount per card would be applicable as follows:
  - Minimum Cart Value:
    - All Categories: INR 2,500
  - Maximum Discount per SBI Mastercard Debit Card:
    - All Categories: INR 250 per card
- \*Customer can avail a maximum discount of INR 250 across all categories combined.
- \*In the event the customer returns any/all products in the order placed during the Offer Period, thereby not maintaining the minimum purchase value, as required to avail the Offer, he/she shall not be eligible for the Offer.
