New Delhi: 5G is an important part of the US and India's shared efforts to build a resilient economy for now and for future, US ambassador Eric Garcetti said on Tuesday, adding that to foster an open, accessible and secure technology ecosystem, the two countries must ensure that "our shared values fuel our shared decisions".

The shared vision of the two nations and their leaders is about digital economy built around transparency and accountability to the people, the rule of law, and

protection of basic rights, the ambassador said.

"India, with its vast population, its thriving digital economy, the use of technology that in some ways is leap-frogging other nations around the world, is poised

to leverage the transformative power of 5G and 6G... to catapult itself to the forefront of the digital revolution," he added, while lauding Prime Minister Narendra Modi's leadership. "India is in such wonder-

ful hands... with your leadership, with the transformative policies that you and this administration are implementing, together with public sector and with private sector, and with community aspect that defines everything that is part of India's rise right now. This is the most exciting nexus in the world, the US-India relationship is where it is at," the ambassador further said.

He was speaking at a workshop organised by the US trade development agency to promote 5G and Next Generation Networks.

The USTDA in a statement said that the rapid growth of India's 5G sector presented a compelling need for infrastructure development, and an opportunity for the US and Indian firms to share expertise, es-

establish new partnerships and leverage private sector financing to support India's digital connectivity goals.

"Facilitating 5G deployment is an increasingly important pillar of the US-India technology partnership and one of the six areas of focus for the US-India ICET (US-India initiative on Critical and Emerging Technology) initiative," it said.

"The United States and India enjoy a strong relationship founded on shared values and mutual benefit. The US and its private sector stand ready to build on this long partnership with India by expanding innovation, investment, and knowledge sharing to achieve shared prosperity and to promote an open, transparent, and inclusive global digital economy," added the agency.

## Manish Sisodia 'manhandled' by cop, claims AAP

New Delhi: The Aam Aadmi Party on Tuesday came down heavily on Delhi Police, alleging that a senior cop manhandled former deputy chief minister Manish Sisodia at Rouse Avenue court at the behest of BJP government. Delhi Police dismissed the claims and termed them "propaganda".

Sisodia was produced before the court in a money laundering case related to the alleged excise policy scam.

The incident allegedly took place when he was being escorted out after the court extended his judicial custody till June 1. According to the party, Sisodia was "pushed and held by the neck" by an ACP.

Senior AAP leaders responded with indignation, with chief minister Arvind Kejriwal tweeting, "Does the police have the right to misbehave with Manish ji like this? Has the police been told from above to do this?" AAP minister Saurabh Bharadwaj alleged the act was carried out on the orders of PMO as part of a larger scheme "to crush AAP leaders and the party itself".

In a tweet later, Delhi Police said the allegation of misbehaviour with Sisodia was "propaganda". "The police response publicised in the video was imperative from a security point of view. It is against the law to issue statements to the media by the accused in judicial custody," it tweeted.

## HC overrules mayor on repoll

New Delhi: Taking a dim view of newly elected mayor Shelly Oberoi's "colourable exercise of power", the Delhi high court Tuesday set aside her decision to call for a repoll to elect six members of the Municipal Corporation of Delhi standing committee.

It directed Oberoi to declare the results of the poll held on February 24 while treating the "disputed vote" to be valid and in favour of BJP councillor Pankaj Luthra.

The court's order came on petitions by BJP councillors Kamaljeet Sehrawat and Shikha Roy against the mayor's decision to order a repoll amid the running feud between the saffron party and AAP.

Justice Purushendra Kumar Kaurav said the mayor, as the returning officer, acted beyond her powers and her decision was impermissible as it was "not based on any material relevant to the issue". The court noted that Oberoi wanted to declare Sarika Chowdhary as elected candidate no. 6 while rejecting one ballot paper.

# Scores join wrestlers in march to mark one month of protest

New Delhi: Amidst heavy police and paramilitary presence, the protesting wrestlers and supporters from all walks of life marched from Jantar Mantar to Kartavya Path at India Gate, holding candles in their hands. The wrestlers have completed a month of their protest at Jantar Mantar demanding the arrest of Wrestling Federation of India president Brij Bhushan Sharan Singh for sexual harassment.

During the march on Tuesday the wrestlers did not stick to their original plan of reaching India Gate on buses, but walked there instead. While police initially persuaded them to drive there on buses because of the possibility of a march affecting the movement of peak-hour traffic, they later allowed them to walk to Kartavya Path.

Around 5pm on Tuesday, approximately 400 people started the march from Jantar Mantar to Kartavya Path. The protesters walked along Ashoka Road, then proceeded along Man Singh Road to Kartavya path. Bhim Army chief Chandrashekhar Azad was also present along with his supporters at the candle march. The protesters were not allowed to march to India Gate, so squatted at Kartavya Path and lighted their candles. Those who did not have candles were asked to

turn on the torchlight function on their mobile phones. Comparing the candlelight march to the protests at the rape of Nirbhaya in 2012, Mandeep, the media in charge of the wrestlers, told the marchers, "It was in 2012 that people gathered here in huge numbers to de-

mand justice for their daughter. Now we have gathered in a similar manner to seek justice for the daughters of this nation." Among those who were present at the march were mothers who had brought along their daughters to teach them what it meant to

fight for justice. Senior citizens too had congregated in large numbers. Shashi Choudhary, 78, accompanied by her friend, Rajni, 65, had come from Gurgaon to join the protest. The duo said they had taken almost all means of public transport to reach the protest site. "We came here 2-3 days ago too to support the wrestlers," said Choudhary. "The man accused by the wrestlers is a member of Parliament and his position is still intact. The girls who bought laurels for our nation have alleged harassment at his hand, but the accused is roaming free. He must be arrested and thoroughly investigated. When the #Metoo movement began action was taken quickly, but in this case nothing is being done. What is the reason for this?"

Many young wrestlers from Haryana joined the protest to support the international wrestlers. Ashish and Saurabh, both 17 years old and who are currently competing at the district level, had arrived from Sonapat in Haryana. "We, as wrestlers, want to support our champions and stand up for them," said Ashish, who aspires to be like one of the protesting stars.

Owing to the crowd, international medallists Bajrang Punia, Vinesh Phogat, Sakshie Malikkh and Sangeeta Phogat climbed on the police barricade to address the crowd.

## Rahul takes truck ride from Ambala to Shimla

**Revision of Electricity Tariff for Bangalore Electricity Supply Company Limited for FY-24**

In exercise of the powers conferred under sections 62, 64 and other provisions of the Electricity Act, 2003, the Karnataka Electricity Regulatory Commission determines and notifies the distribution and retail supply tariff of BESCOM for FY-24 on 12.05.2023.

**Tariff highlights are as under:**

- The tariff determined in the Tariff Order-2023 dated 12.05.2023 shall come into effect for the electricity consumed from the first meter reading date falling on or after 1st April 2023.
- Overall increase in the average Tariff hike is 70 paise per unit for all LT & HT categories.
- Out of 70 paise increase, 57 paise is being recovered through Fixed Charges and the remaining 13 paise is being recovered as Energy Charges.
- The overall increase in tariff is 7.84% over the existing tariff.
- The Discounted Energy Rate Scheme (DERS), which was applicable to HT consumers is now extended to LT Industries (LT-5) and LT Commercial (LT-3) Installations with a sanctioned load of 50 KW and above.
- In Discounted Energy Rate Scheme (DERS) the energy charges are reduced to Rs.5.00 per unit as against the existing rate of Rs.6.00 per unit
- The Special Incentive Scheme (SIS) is continued until further orders.
- To encourage use of electric vehicles, the Energy charges for EV charging stations has been reduced to Rs.4.50 per unit against the existing rate of Rs.5.00 per unit
- To promote setting up of Data Centres in the State, industrial tariff is extended to Data Centres.
- Rebate for Micro and Small industries of 50 paise per unit in the Energy Charges is extended until further orders to LT-5 category as certified by Government.
- As a part of Tariff Rationalisation & simplification, Urban and Rural categories are merged into one category and a rebate of 30 paise per unit is allowed to all the rural consumers.
- Green tariff of additional 50 paise per unit over and above the applicable tariff at their option to HT industries and HT commercial, is continued.
- Concessional tariff to BMRCL & Railway traction is continued.
- Introduced non-telescopic tariff slabs in respect of all the LT categories except LT Industrial tariff, as part of the Tariff Rationalization.
- Goushalas are extended with domestic tariff

## Suicide or murder? IIT-Kgp student's remains exhumed

Dibrugarh: The mortal remains of 23-year-old IIT-Kharagpur student Faizan Ahmed were exhumed Tuesday in upper Assam's Dibrugarh town following a Calcutta high court order for a second autopsy to find out whether his death in the premier institute on October 14 last year was a case of suicide or murder.

The exhumation at Amolapatty burial ground was overseen by a four-member Bengal police team, a magistrate, and forensic experts from Dibrugarh's Assam Medical College and Hospital (AMCH) and the Directorate of Forensic Science in Guwahati, while local police stood guard and provided help. Faizan's family members were also present.

The remains were put in a coffin and taken to the morgue of AMCH. The Bengal police team

will fly with the coffin to Kolkata, where a second autopsy will be done at the Medical College and Hospital in accordance with the HC order.

The decomposed body of Faizan, a third-year mechanical engineering student from Assam, was found in a hostel room that was not his. While IIT-Kharagpur said he died by suicide, his parents Salim and Rehana from Assam's Tinsukia filed a petition in the Calcutta HC on October 31 last year, alleging that their son was murdered.

Questions about the prevalence of ragging in the institute surfaced in the wake of his death. Faizan's parents had cited a Facebook post—ostensibly uploaded by IIT students—that suggested he had protested against some of his seniors for ragging. On April 25 this year, the HC passed an order calling for the exhumation of his body, saying it is necessary to ascertain the cause of death.
