- The **Bidders** should get themselves registered https://BAANKNET.com.by providing requisite KYC documents and registration fee as per the practice followed by https://BAANKNET.com well before the auction date. The registration process takes minimum of two working days. (Registration process is detailed on the above website).
- (b) The Intending bidder should transfer his EMD amount by means of challan generated on his bidder account maintained with BAANKNET.com at https://BAANKNET.com. by means of NEFT/ RTGS transfer from his bank account.
- (c) The Intending bidder should take care that the EMD is transferred at least one day before the date of auction and confirm that his wallet maintained with https://BAANKNET.com Ltd is reflecting the EMD amount without which the system will not allow the bidder to participate in the e-auction.
