1. Individuals/ Firms / Companies having valid authorization for e-Waste recycling from the **State Pollution Control Board.** The bidder who does not have authorization certificate from **State Pollution Control Board**, such firms **will not allow in e-forward auction and will be rejected** in technical bid.

Bidders have to submit EMD (Earnest Money Deposit) of Rs. 7000/- (Rupees seven thousand only) in the form of demand draft in the favour of "The AGM(P&E), SBI LHO, Patna" payable at Patna. The original hard copy of the EMD (DD/Bankers Cheque) must be submitted at the office of <u>"The Assistant General Manager (P & E), State Bank of India, Premises & Estate Department, 8TH FLOOR, LOCAL HEAD OFFICE, WEST GANDHI MAIDAN, PATNA - 800001 on or before 05:00 P.M on 04.08.2025. - 2. The entire e-waste items will be sold as a single lot on as is, where is basis to the successful bidder(s) and no part quotation will be considered.
- 3. Each bid document must contain Earnest Money Deposit (EMD) of Rs 7000/- (Rupees seven thousand only) in the form of Demand Draft on any Nationalized/Scheduled Bank in Favour of "The Assistant General Manager (P & E), SBI LHO, Patna" and payable at Patna. Bids received without EMD shall summarily be rejected. Earnest Money deposit (EMD) is exempted for agencies registered under NSIC or coming under the definition of Micro and Small Industries and holding valid registration certificates covering the tendered items/services. Declaration of Udyog Aadhar Memorandum (UAM) by the MSE parties on Central Public Procurement Portal (CPPP) shall be mandatory. (b) In case, the successful bidder deposits the full amount within a stipulated period but fails to lift the articles in the scheduled time, this office shall not take responsibility for safe custody of the articles. (c) No damage shall be caused to the existing property of this office or any other offices in the premises while removing the material from the site Any loss damage to the property of this office or any offices in the premises or injury or personal accident suffered by any person due to negligence or action of the successful bidder or his authorized worker/supervisor will be borne by successful bidder.
