SBI Regional Business Office, Tezpur invites offers in **TWO BID SYSTEM (TECHNICAL BID and PRICE BID)**, from **owners / Power of Attorney holders** for premises on lease rental basis for Commercial / Office cum residential use having built up area of **approx. 3500-4000 SQFT (+/- 10%) located preferably within 500-meter radius of SBI Dirang branch premise** at Dirang, P.O. Dirang, District - West Kameng, Arunachal Pradesh. In case of approach road, the road to the building shall be well built up and adequately wide for uninterrupted movement of at least two four-wheeler vehicles simultaneously. The premises should be an **Independent Building** having car parking area for **minimum 8 to 10 no's four wheelers and sufficient open space for conducting function/office program for at least 50 persons within the building campus**. Preference will be given for building/ premises located in **ground floor or first floor**. The premises should also be suitable for planning of interior layout for OTC as per Bank's requirements. If the premises not found suitable for layout planning, the offer may be rejected, and price bid of such bidder will not be opened. TERMS AND CONDITIONS FOR LASING OF OFFICE CUM RESIDENTIAL PREMISES

The tender consists of two parts viz. the Technical Bid (mentioning the terms and conditions, details of offer) and the Price Bid. Duly signed and complete **separate Technical and Price Bids** are to be submitted for each offer in case the lessors wish to apply for multiple offers. The Technical Bid and Price Bid for the proposal should be enclosed in separate sealed envelopes and these two envelopes are to be placed in a single cover super scribing **“TENDER FOR LEASING OF PREMISES FOR STATE BANK OF INDIA, OTC DIRANG, DIST- WEST KAMENG, ARUNACHAL PRADESH”** and should be submitted to the **“Regional Manager, State Bank of India, Regional Business Office, Tezpur, P.O. Ketekibari, District- Sonitpur, Assam, 784154” on or before 5:00 pm on 20.08.2025.**

TERMS AND CONDITIONS

1.1 The successful bidder/lessor should have clear and absolute title to the premises and furnish legal title report from Bank's empanelled advocate at his own cost. The successful bidder/lessor will have to execute the lease deed as per the standard terms and conditions finalized by the Bank for the purpose and the stamp duty and registration charges of the lease deed will be shared equally (50:50) by the lessors and the Bank. The initial period of lease will be 5 years and will be further renewed for 5 years (viz. total lease period 10 years) with requisite exit clause to facilitate full / part de-hiring of space by the Bank only during the pendency of the lease. As regards increase or decrease in rents payable, increase in rent if any shall be subject to market conditions. After 10 years, rent can be negotiated and finalized with mutual agreement so that new lease can be executed for further term of 5 years.

1.2 Tender documents received after due date and time i.e., **05:00 PM on 20.08.2025** shall be rejected.

1.3 The bidders are requested to submit the tender documents in separate envelope superscribed on top of the envelope as **Technical Bid** and **Price Bid** as the case may be, duly filled in with relevant documents/information at the above-mentioned address.

1.4 **All columns of the tender documents must be duly filled in and no column should be left blank. All pages of the tender documents (Technical and Price Bid) are to be signed by the authorized signatory of the lessor.** Any over-writing or use of white ink is to be duly initialed by the bidder. Bank reserves the right to reject incomplete tenders.

1.5 In case the space in the tender document is found insufficient, the bidders may attach separate sheets.

1.6 The offer should remain valid at least for a period of **03 (three) months** to be reckoned from the last date of submission of offer i.e., **20.08.2025**.

1.7 There should not be any deviation in terms and conditions as have been stipulated in the tender documents. However, in the event of imposition of any other conditions, which may lead to a deviation with respect to the terms and conditions as mentioned in the tender document, the lessor is required to attach a separate sheet "list of deviations", if any.

1.8 The Technical Bid will be opened after the last date of submission of bid and after which technical scrutiny will be carried out by the Bank's internal Committee. **The Price Bid will be opened at a later date (which will be informed in due time)** in the presence of the bidders who wish to be present at the above-mentioned office. All bidders are advised in their own interest to be present on that date at the specified time.

1.9 Bank reserves the right to accept or reject any or all the tenders without assigning any reason thereof. In case of exigency and depending upon the suitability, Bank may as well accept more than one proposal to suit its total requirements.

1.10 Canvassing in any form will disqualify the tenderer. No brokers will be entertained.

1.11 The short-listed bidders will be informed by the Bank for arranging site inspection of the premises offered by them.

1.12 Income Tax and other statutory clearances shall be obtained by the bidders at their own cost as and when required. All payments to the successful bidder/lessor shall be made by Account Payee Cheque or RTGS/NEFT.

1.13 Preference will be given to the exclusive building/floor in the building having ample parking space in the compound / basement of the building & dedicated transformer with exclusive 20-25 KVA power load.

1.14 The details of parameters and its weightage for technical score has been incorporated in Annexure-I. The selection of premises will be done based on **techno-commercial evaluation**. **70% weightage will be given for technical parameters and 30% for price bid**. The score finalized by the Committee of the Bank in respect of technical parameters will be final and binding to the applicant.

1.15 The income tax and other taxes as applicable will be deducted at source while paying the rentals per month. However, the landlord will be required to submit bill to the concerned Branch Manager every month for the rent due to them indicating the GST component also in the bill separately. The bill also should contain the GST No. of the landlord, apart from name, address etc. of the landlord and the serial number of the bill. GST levied on rent paid by landlord directly, shall be reimbursed by the Bank to the landlord on production of challan/receipt of tax to the Govt. indicating name, address and the service tax/GST registration number of the landlord.

1.16 Mode of measurement for premises is as follows:

Rentable area of the premises should be clearly mentioned as **built-up area as per IS code 3861-1975 which could be always measured jointly by the Bank and the landlord**.

1.17 The floor wise area viz. Ground, First, if any, etc with the corresponding rate for rent/taxes should be mentioned in the Price Bid.

1.18 The successful bidder/lessor should arrange to obtain the municipal license/NOC/approval of layouts etc from Local Civic Authority/Collector/Town Planning etc. along with the required **electrical power load (Transformer) of approximately 25 KW**. NOC and the space required for installation and running of the generator set, provision of installation of AC Outdoors Units, Bank's Signage at front & side fascia, Earth stations, VSAT, etc will also have to be provided within the compound by the bidder/ lessor **at no extra cost to the Bank**.

1.19 The premises should be suitable for at least 8-10 rooms, hall area, dinning space, kitchen room, storeroom and balcony. Bidders should obtain and furnish the structural stability certificate from the licensed structural consultant at his own cost.

1.20 The bidder shall obtain/submit the proposal to Municipal Corporation/Collector/Town Planning etc. for the approval of plans immediately after receipt of approved plans along with other related documents so the interior renovation work can commence, in case of unfurnished premises.

1.21 After selection of the suitable premises, bank will prepare plan and layout for rooms, hall, washroom, kitchen, window, door etc. and will advise the bidder for completion of civil work within 3 months from the date of submission. The bidder should complete all civil works as advised with his own cost.

1.22 Permitting the Bank to carry out any alteration / addition works in connection with improving the ambience.

1.23 The bank shall not be bound to accept the lowest tender (L1) and reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever. Quoted rate by the bidders is not final and Bank reserves the right to negotiate further on quoted rent if felt very highly quoted.

1.24 After the completion of the Interior, Electrical, AC works, etc. the lease agreement will be executed, and the rent payable shall be reckoned from the date of handover of the premises by the landlord. The lease agreement will include inter-alia, a suitable exit clause and provision of de-hiring of part/full premises.

1.25 Rent should be inclusive of all present and future taxes whatsoever, municipal charges, society charges, maintenance. However, GST shall be paid extra at applicable rate and manner.



1.26 Electricity charges will be borne by the Bank, but water supply should be maintained by the Landlord/owner within the rent. The landlord should arrange for power load approx. 20-25 KVA power load. Installation of transformer and other charges should be borne by the landlord. However, only load security if demanded by the power dept., will be borne by the bank.

1.27 All civil works such as washrooms with all fixtures etc. kitchen with brick walls, ramp with hand railing, vitrified tile flooring, internal painting with distemper and external painting with waterproof paint, aluminum sliding windows, safety grill for windows and all glass surfaces, etc. as advised by the Bank will be carried out by landlord's at his own cost before handing over possession to the Bank (for further clarification, kindly refer "Scope of Works to be arranged by Successful Bidder").

1.28 Interior works like loose furniture, drywall partition system, cubicles, cabins, false ceiling, AC lighting fixtures, signage boards, cabinets, electrical wiring etc., will be done by the Bank at its own cost as per requirement. The landlord should not object to necessary wall drilling/cutting required for Interior, Electrical, AC works, etc. Space should also be provided by the landlord for DG set installation with no extra cost.

1.29 Bank reserves the right to cancel the tender at any stage before finalization and issuance of offer letter intending for lease without assigning any reason whatsoever.

1.30 Bank also reserves the right to accept or reject any or all bids or to re-tender at Bank's sole discretion without assigning any reason to anybody whatsoever.

1.31 Pre-bid meeting will be held on at the Office of the Regional Manager, State bank of India, Regional Business Office, Tezpur, P.O. Ketekibari, District- Sonitpur, Assam, 784154. All clarification, doubts to be discussed in pre-bid meeting only. Any kind of objection/ dispute if arises or pointed out by the bidders on any point/ clause after the meet or any stage after opening of technical/ financial bid will not be entertained.

SCOPE OF WORKS TO BE ARRANGED BY SUCCESSFUL BIDDER

Civil works:

A. For Officer Transit Camp (OTC) area:

All the civil works for the OTC are to be done by landlord to make the premises at per with a 3-star quality hotel premises. The gist of civil works to be done are given below.

1. 600 mm x 600 mm / 1200 mm X 600 MM Double charged Vitrified tiles of reputed brand to be laid in floor (**Kajaria/Jhonson/Nitco**).
2. Sufficient space for at least 8-10 no's single room of approx. size 10' x 11' with attached toilet and two no's room for VIPs of minimum size 15' x 16' with attached toilet.
3. Sufficient Space for one kitchen with dining hall of proper sitting space.
4. Space for one living room cum reception for OTC.
5. UPVC windows along with MS grill of approved design with painting to be provided in all the windows by the landlord.
6. Premium Quality Flush doors to be provided in all rooms by the landlord.
7. Toilets/Bathrooms are to be provided with anti-skid floor tiles and wall tiles up to full height of wall of approved design and reputed brands.
8. All the fittings including water heater (geyser) of all bathrooms shall be of reputed brands such as **Kohler/ American standard/ Jaquar to be installed by landlord**.
9. Kitchen to be provided with kitchen slab finished with granite top and edge along with a sink provision.
10. Walls to be finished with putty, primer and premium quality plastic acrylic interior paints of approved makes by Bank (**Asian/Berger**).
11. External walls of building shall be finished with premium quality exterior weather paints able to withstand against rainwater (**Asian/Berger**).
12. Periodical repainting of the buildings and rooms to be done by landlord.
13. The designated parking space along with shed for parking of cars to be provided by landlord as per Bank's requirements.
14. Paver's tiles/blocks to be provided in the open space within the campus as per Bank's requirements.
15. The landlord will provide 24x7 running water supply with overhead water tank/ underground borewell facility.
16. Landlord will arrange all sanitary fittings along with plumbing works for bathrooms and kitchen as per the layout.

1. Transformer of minimum **25 KW** load to be provided by landlord.

1. Each of the above parameters given marks.

Total Marks 100.

Three premises shortlisted – A, B, & C.

They get following marks

A-78, B-70, C-54

2. Convert them to percentiles

A: $(78/78) * 100 = 100$

B: $(70/78) * 100 = 89.74$

C: $(54/78) * 100 = 69.23$

Financial quotes for three premises are as follows:

A: Rs.300 per sqm for floor area

B: Rs.250 per sqm for floor area

C: Rs.210 per sqm for floor area

3. As desired on is lowest, to work out percentile score, we will get

C: $(210/210) * 100 = 100$

B: $(210/250) * 100 = 89.74$

A: $(210/300) * 100 = 70$

4. Technical score (percentile form)

A: $(78/78) * 100 = 100$

B: $(70/78) * 100 = 89.74$

C: $(54/78) * 100 = 69.23$

5. Financial score (percentile form)
