NOTICE

EMPANELMENT OF ARCHITECTS / CONSULTANTS FOR CIVIL, ELECTRICAL, AIR-CONDITIONING, FIRE FIGHTING AND INTERIOR & FURNISHING WORKS AT THE BANK'S VARIOUS BRANCHES & OFFICES AND RESIDENTIAL PREMISES AT DIFFERENT LOCATIONS IN THE STATES OF WEST BENGAL & SIKKIM, AND, UNION TERRITORY OF ANDAMAN & NICOBAR ISLANDS

State Bank of India, Local Head Office, Kolkata invites applications for empanelment of Architects / Consultancy Firms for the works of Civil, Electrical, Air-conditioning, Fire Fighting and Interior & Furnishing at Bank's various branches & offices and residential premises in the states of West Bengal & Sikkim, and, the Union Territory of Andaman & Nicobar Islands. The Architects / Consultancy Firms interested in applying should be specialized in managing complete work in the relevant field by adopting cost effective methods using latest materials (complying green building norms).

They should have adequate exposure in designing the infrastructural facilities like Civil, Electrical, Air-Conditioning, Interior & Furnishing, Fire Fighting works etc. along with planning and designing of proper seating arrangements and assuming overall responsibility for the above works of the offices & branches. Those architects who are already on Bank's panel should also apply afresh for re-casting of panel.

Detailed application forms and further details for empanelment can be downloaded from Bank's website www.bank.sbi or www.sbi.co.in under "PROCUREMENT NEWS" from 11.08.2025 to 12.09.2025 and should be submitted by 5 PM on or before 12.09.2025 to the address mentioned at the end of notice.

- 2. The different types of works to be handled by the Architects / Consultancy Firms are Civil, Electrical, Air-Conditioning, Fire Fighting and Interior & Furnishing works under the following groups / categories:
- (i) Projects costing up to ₹1.0 Crore
- (ii) Projects costing above ₹1.0 Crore up to ₹5.0 Crores
- 3. Minimum Eligibility Criteria:
- 3.1 They should have adequate exposure in designing the infrastructural facility like Civil work, Electrical, Air-Conditioning, Fire Fighting etc. Only those Architects / Consultants will be considered for Interior & Furnishing work who have adequate

- experience in planning and designing, providing for proper seating arrangements and assuming overall responsibility for the interiors of the offices & branches.
- 3.2 The Architects should have Graduate / Post graduate diploma in architecture either from India or Abroad and/or have done substantial amount of work as architect in India for period of more than three years.
- 3.3 The Architects / Consultants firms should be members of Indian Institute of Architects (IIA) / Council of Architecture (COA) / Institution of Engineers (India) or any other recognized professional institute.
- 3.4 They must have PAN No. & should have filed IT returns for FY 2021-22, 2022-23 & 2023-24.
- 3.5 They must have GST number.
- 3.6 Average annual financial turnover during the last 3 years, ending 31st March of the last financial year, should be minimum 30% of estimated fees of the projects handled by the firm. Tentative turnover values for the two different groups for maximum project values are given below –

SI. No.	Group	Eligibility Limit (Amount in Rupees)	Average Turnover of Last 3 Years (Minimum)
1	Group 1	Projects costing up to ₹1.0 Crore	₹1.35 lacs
2	Group 2	Projects costing above ₹1.0 Crore up to ₹5.0 Crores	₹6.00 lacs

- 3.7 The Architects / Consultants firms should have successfully executed similar nature of comparable magnitude/value in a Govt. organization, Govt. undertaking / enterprise companies, other Govt. financial institutions, Public Sector Banks or Units and reputed private organizations, i.e., Listed Corporate Bodies having CIN while working as Architects under the same name and should comply with any of the following during past seven years
 - a. Three similar completed projects costing not less than 40% of the respective limit of empanelment, Or,
 - b. Two similar completed projects costing not less than 50% of the respective limit of empanelment, Or,
 - c. One similar completed project costing not less than 80% of the respective limit of empanelment.

NOTE: At least one work should have been completed within last 3 years ending on 31.03.2025.

Definition of similar works: Related works done in Commercial Establishments /
Hospitals / Nationalized Banks / Institutional Organizations / Large Private Sector
Establishments (Listed Corporate Bodies having CIN) / PSUs / PSBs / Central &
State Government Departments, etc.

- 3.8 The Architects / Consultants should have adequate number of technical staff working with him for preparation of drawings, estimates, supervision of work, checking of bills, etc.
- ☐ Those Architects / Consultancy Firms having experience in the field for not less than 7 years need only to apply.
- Year of establishment and proof of registration with Indian Institute of Architects (IIA) / Council of Architecture (COA) must be submitted.
- 3.9 If the application form is not properly filled in and does not contain all required information with enclosures as stated in the technical bid, the application will not be entertained.
- 3.10 The Architects / Consultants empaneled in Group 2 can participate in the projects costing up to ₹1.0 Crore along with the Architects / Consultants empaneled in Group 1. However, the Architects / Consultants empaneled in Group 1 cannot participate in the projects costing above ₹1.0 Crore up to ₹5.0 Crore.
- 3.11 The Firm / Agency / Organization should have or willing to have well established office in at least one city in the states of West Bengal & Sikkim, and, the Union Territory of Andaman & Nicobar Islands. Applicant should furnish their office address and necessary address proof.
- 3.12 The applicant shall agree and authorize SBI to obtain the confidential report from the clients of the applicant, to obtain an idea about the quality of work executed and to obtain credit opinion from applicant's bank.
- 3.13 The Architects / Consultants having near relatives in the State Bank of India may not be considered for empanelment.
- 3.14 The status of the company / firm (Proprietorship / Ltd. / Pvt. Ltd. / Partnership etc.) shall be the same while assessing experience.
- It is desirable that all the applicants should be registered in Government e-Market (GeM) portal.
- 3.15 Period of empanelment shall be for 3 years from the date of approval by the Competent Authority of the Bank. Performance of all the prospective empaneled Architects / Consultants will be reviewed periodically (at least once in year) for determining continuation or removal from the panel.
- 4. Applicants willing to apply for empanelment in both the groups / categories <u>are</u> <u>required to submit separate applications for each group / category.</u> However, they must comply with the respective criteria for the categories, otherwise their application may be rejected.
- 5. The Architects / Consultancy Firms applying for the empanelment <u>are to superscribe the group</u> for which they are applying on the cover of the application e.g. "ARCHITECTS FOR Group 1 : UPTO ₹1.0 CRORE".
- 6. Intending applicants are to submit application for one category as per the eligibility criteria with an option of their willingness to work in lower category, if applied for higher

category. However, in the opinion of the Bank, if the credential and supporting documents of any such Architects are not found to be matching with the laid down criteria for a specific category applied for, these Architects may be considered for lower category.

- 7. The architects already in Bank's panel need to apply afresh. Their empanelment will be reviewed with the eligibility criteria as above along with their performance in Bank so far. Their participation in Bank's tender / works in last 7 (seven) years will also be considered.
- 8. Applications which are not properly filled may not be considered for processing and are liable to be rejected.
- 9. Application received after stipulated last date (during working hours of the Bank) will not be considered.
- 10. The applicant should not have abandoned any work or rescinded any part of their contract or been disqualified by the client during the last 5 years.
- 11. The applicant should not have been blacklisted or debarred from participating in any tender for similar services by a Government Department, Organization whether public or private, in last five years and must not be under rigors of any such blacklisting or debarment at the time of submission of documents for empanelment.
- 12. Applications complete in all respect along with relevant documents & in enclosed format are to be put in sealed envelope, duly superscribing the following –

INSTRUCTIONS TO ALL THE APPLICANTS

EMPANELMENT OF ARCHITECTS / CONSULTANTS FOR CIVIL, ELECTRICAL, AIR-CONDITIONING, FIRE FIGHTING AND INTERIOR & FURNISHING WORKS IN KOLKATA CIRCLE UNDER SBI LHO KOLKATA

- 1. Intending applicants are required to submit their applications with full bio-data giving details about their organization, experience, technical personnel in their organization, competence and adequate evidence of their financial standing etc. in the enclosed form which will be kept confidential.
- 2. While deciding upon the empanelment of Firms / Organizations, emphasis will be given on the ability and competence of applicants to do good quality works within the specified time schedule and in close co-ordination with Bank as well as other agencies.
- 3. Decision of Bank in regard to selection of Firms / Organizations will be final. The Bank is not bound to assign any reason for acceptance / rejection of any application.
- 4. Each page of the application shall be signed. The application shall be signed by persons/ persons on behalf of the organization having necessary authorization / Power of Attorney to do so (Certified copies to be enclosed).
- 5. If the space in the proforma is insufficient for furnishing full details, such information may be supplemented on separate sheets of paper, stating therein the part of the proforma and serial number. Separate sheets shall be used for each part. **However, the format shall be as per proforma.**
- 6. Applications containing false, incomplete and/or inadequate information are liable to be rejected. Also, mere fulfillment of eligibility criteria does not guarantee selection.
- 7. Applicants / Architects selected in the SBI Kolkata Circle panel will be informed about the same after finalization of the panel. The decision of the Bank / SBI towards empanelment shall be final, binding and non-objectionable on the part of the applicants.
- 8. Canvassing in any form in connection with selection is strictly prohibited and the application of such persons / organizations who resort to canvassing will be liable to rejection.
- 9. Applicants / Architects, who are already empanelled with SBI and are on the present panel need to apply afresh and no separate intimation, will be given to them. Firm / Organizations empanelled in a category shall also be considered for works under categories below it.
- 10. SBI reserves its right to reject any or all the applications without assigning any reasons, whatsoever thereof. Incomplete / partly filled applications without relevant

enclosures may not be considered for evaluation. Disputes, if any, regarding the empanelment shall be within the jurisdiction of Court in Kolkata only.

- 11. It will not be binding on SBI to invite all the empaneled Architects to participate in bidding for various works. The Bank may prepare a select list of Architects out of the empanelled vendors to participate in the bidding process of any work.
- 12. Bank is not responsible for the late receipt or non receipt due to postal delay, strikes or any other reasons.
