## 13 Other conditions

- (a). The Bidders should get themselves registered on <a href="https://BAANKNET.com">https://BAANKNET.com</a> by providing requisite KYC documents and registration fee as per the practice followed by <a href="https://BAANKNET.com">https://BAANKNET.com</a> well before the auction date. The registration process takes minimum of two working days. (Registration process is detailed on the above website).
- (b). The Intending bidder should transfer his EMD amount by means of challan generated on his bidder account maintained with <a href="https://BAANKNET.com">https://BAANKNET.com</a> by means of NEFT/ RTGS transfer from his bank account.
- (c) The Intending bidder should take care that the EMD is transferred at least one day before the date of auction and confirm that his wallet maintained with <a href="https://BAANKNET.com">https://BAANKNET.com</a> reflecting the EMD amount without which the system will not allow the bidder to participate in the e-auction.
