(b) The Intending bidder should transfer his EMD amount by means of challan generated on his bidder account maintained with BAANKNET.com at <a href="https://BAANKNET.com">https://BAANKNET.com</a> at <a href="https://BAANKNET.com">https://BAANKNET.com</a> by means of NEFT/ RTGS transfer from his bank account.  (c) The Intending bidder should take care that the EMD is transferred at least one day before the date of auction and confirm that his wallet maintained with BAANKNET.com Ltd is reflecting the EMD amount without which the system will not allow the bidder to participate in the e-auction.
