

Future Group (9th Aug'19 – 15th Aug'19)
Program-Terms & Conditions

- 1) This marketing Program (Program) is from State Bank of India ("Bank") under an arrangement with Future Group ("Merchant") and is open to all residents of India holding a valid SBI Debit Card ("Cardholder").
- 2) The validity of the Program is from 9th Aug'19 – 15th Aug'19 (Both days included) unless extended by Bank and Merchant by mutual consent in writing.
- 3) Under this Program:
 - a. A cardholder who swipes his/her SBI Debit Card for a minimum value of Rs. 4,000/- and above only can avail 7% instant discount on each qualifying transaction at the participating merchant stores (i.e., at Big Bazaar, Food Bazaar, FBB, Hyper city, E-zone Merchant).
 - b. Offer will also be applicable at www.fbbonline.in during offer period.
