e) During e-Auction, if no bid is received within specified time, State bank of India at its discretion may decide to revise opening price/ scrap the e-Auction process / process /proceed with conventional mode of e tendering.

f) The Bank /service provider for e-Auction shall have not have any liability towards bidders for any interruption or delay in access to the site irrespective of the causes.
