Bank shall not entertain bids received late due to any delay on account of delivery by the courier agency/speed post or any other mode for the reasons whatsoever. 2. Tenders received without EMD/ MSME Certificate along with Bid Declaration Certificate shall be summarily rejected.

9	Validity of tenders.	Rates quoted should remain valid for a period of 3(three) months.
10	Date of Commencement of work	1 st Day of Succeeding month of the Work Order or as advised in the work Order.
