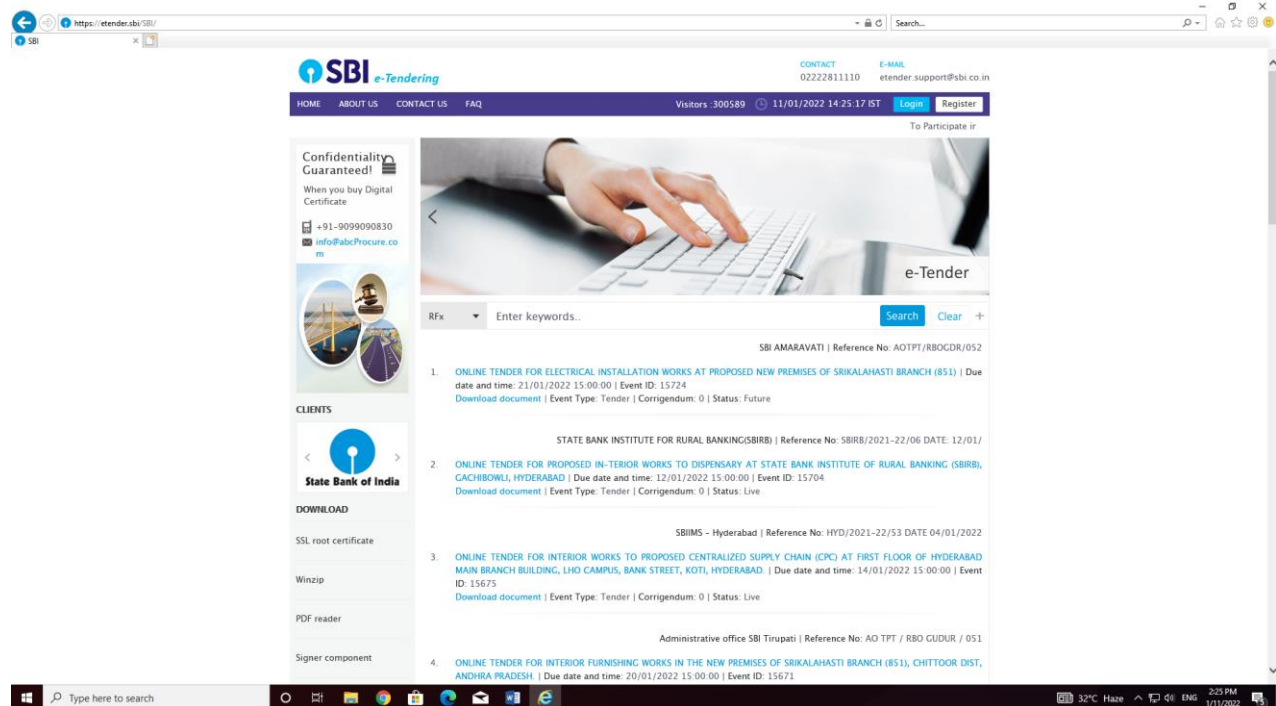

1. Intending applicants are required to submit their applications with full bio-data giving details about their address proof, experience, etc. in the enclosed form which will be kept confidential.
2. While deciding upon the empanelment of Firms/ Individual, great emphasis will be given on the ability and competence of applicants to do good quality works within the specified time schedule and in close co-ordination with Bank as well as other agencies.
3. Decision of the Bank in regard to selection of Firms/ Individual will be final. The Bank is not bound to assign any reason for acceptance/ rejection of any applications.
4. Each page of the this notification should be signed and shall be uploaded online. The application shall be signed by persons/ persons on behalf of the organization having necessary authorization/ Power of Attorney to do so (Certified copies to be enclosed).
5. If the space in the proforma is insufficient for furnishing full details, such information may be supplemented on separate sheets of paper, stating therein the part of the performa and serial number. Separate sheets shall be used for each part. **However, the format shall be as per performa.**

9. After empanelment, Bank shall invite rate through e-tendering for 15 KVA-125 KVA DG set from empanelled vendors only. The lowest bidder rate for each capacity of DG shall be fixed for a period of one year.
10. Those Existing vendors of branches/ offices need also apply fresh for empanelment.

11. Canvassing in any form in connection with selection is strictly prohibited and the application of such persons/firms who resort to canvassing will be liable to rejection.
12. Before applying please ensure that vendor should have valid **e-mail Id & Digital Signature Certificate (Class III with signing & encryption)**, **internet connection** for participation in e-tendering.
13. The contract period of generator installation shall be 3 years from date of installation and which shall be further renewable for a period of 3 three years/total contract period shall not exceed more than six years.
14. The applicant shall agree and authorize the Bank to obtain the confidential report from the clients of the applicant, to obtain an idea about the quality of work executed and to obtain credit opinion from applicant's bank.
