#### **Terms and conditions**

- The validity of agreement will be for three years.
- The bid for Maximum discount on MRP will be selected for the contract of medicine and medical equipment/ medical devices/ supplies.
- The medicine supplier will supply all the medicines within three days of receipts of list of medicines
  from the bank. In the event of supplier failing to supply drugs within three days and bank is
  constrained to purchase same at market from other sources than supplier shall indemnify the bank
  for difference in the rate offered by supplier and market rate at which medicine purchase by bank.
  Further supplier shall also be liable to compensate the bank for its default in timely supply of
  medicine, which shall be the expenses born by the bank over and above the cost of the purchasing
  medicines at market price and in this regard requisite documents shall be provided to supplier and
  supplier shall not object/ dispute in this regard.
- That all the medicines will be delivered by the supplier to, State Bank of India, Local Head office, Lucknow at its dispensary situated at its 1st floor, Moti Mahal Marg, Hazaratganj, Lucknow, On its own cost and expenses. In event of any damage found in drugs/ medicines which occurred during transit/ supply of medicines at designated place and address then supplier alone shall be responsible for the same and he will not be paid for the damaged drugs/ medicines/ medical equipment's/ devices.
- The expired medicines will be changed with other medicines or same medicines or may be adjusted in next bill with the same purchased price.
- That bills for medicines will be paid after verification of quality and quantity of medicines by the bank.
- That supplier will provide copies of **Valid drug license** to Bank every year in the month of December.
- That the supplier will inform the bank immediately, in case of any changes are being made in the constitution of the firm/company/ individual.
- That supplier will supply the medicines in case of emergency immediately for which necessary adjustment will be done in the bills to be paid in the coming month.
- That bank reserves the right to cancel the agreement by giving one month notice at the recorded address of the supplier without assigning any reason.
- The supplier shall always supply drugs/ medicines as per list of medicine issued by the Bank and same shall be newly manufactured and within the expiry period. The supplier shall ensure that drugs/ medicines are of specified manufacturer and brand. The supplier shall exclusively be liable for supply of any adulterated and spurious drugs/ medicines and shall fully indemnify the Bank in case of any loss is suffered by the Bank or its employee on account of supply of expired / adulterated/ spurious drugs/ medicines supplied by it.
- That in the event of any dispute / difference regarding/or arising, this agreement shall be subject to the exclusive jurisdiction of the court situated at Lucknow.
- That Supplier shall ensure compliance of applicable relevant rules, regulations and other laws as amended time to time regarding supply of drugs/ medicines/ medical equipment's/ devices and will always keep the bank indemnified in this regard.
