(ii) The contractor shall specify the category for which they are submitting the application for empanelment. The application in the prescribed format with all supporting documents in sealed envelope and superscribed as <u>'APPLICATION FOR EMPANELMENT OF CONTRACTORS FOR COMPOSITE WORKS - CATEGORY :</u> <u>Rs LAKHS</u>' shall be submitted at the below office address before the due date and time for receipt of application.

(iii) The applicants who are interested in applying for more than one Category should submit separate applications for each Category along with the certified copies of supporting documents. Applicants mentioning more than one category in the same application shall be considered only for one category. Similarly applicants not mentioning the category for which he has applied will be considered for the lowest category only.

Note: Contractors who are empanelled for higher category will automatically become eligible for undertaking works under lower category. For eg. If a contractor is qualified in Rs200 lacs category, he is allowed to participate in tenders for both Rs100lacs and Rs50 lacs category also.

(iv) The contractors/vendors empaneled by SBI in the past for the individual trades like Civil, Interior, Electrical, AC works need to apply afresh for becoming the Composite contractor.

(v) All the pages of application shall be duly signed with stamp of firm by the contractors, else their application shall be summarily rejected.

(vi) The intending applicants are categorically advised to submit the empanelment documents strictly in the attached formats only.

(vii) Any addition/ alteration to the application format shall lead to rejection of the application submitted by the contractor for the empanelment under this notice.

(viii) The information required should be neatly filled/typed in <u>each and every col-</u> <u>umns and rows</u> of the Formats. <u>The applications received with "partly filled formats"</u> <u>or not containing desired information in each and every columns/points/row of vari-</u> <u>ous annexures shall be treated as INCOMPLETE and such applications shall be</u> <u>summarily rejected without any intimation/ reference to the applicant and at</u> <u>the applicant's risk and responsibility.</u>

(ix) However, if the Bank desires to collect additional information from the applicant in connection with the empanelment process, the same will be intimated by email and the applicant shall submit the same within the time prescribed in the email.

(x) <u>The applicants are categorically advised to refrain from mentioning the remark</u> <u>"AS PER ATTACHEMENT / ENCLOSURES" in their applications and annexures to avoid rejection of their applications</u>.

(xi) All the details must be incorporated in the application form downloaded from the SBI's website. Incomplete applications / not fully filled form will be rejected.

F. GENERAL TERMS & CONDITIONS

(i) The prequalification criteria mentioned in this notice inviting application is minimum requirement, in each category.

(ii) The empanelment of contractors in each category shall be considered purely on merits, performance of the contractor, verification of their credentials / inspection of work for quality, infrastructure feedback / confidential reports of the firms/applicant received from other employers etc. Hence, merely fulfilling the prescribed minimum prequalification criteria shall not entitle the contractor for their empanelment with SBI.

(iii) SBI reserves its right to empanel contractor as per its needs in each category. The applicant must fulfill the eligibility criteria for each Category of the work individually.

(iv) The empanelment of contractors shall be considered on merits within the sole discretion of SBI and cannot be claimed as right by the applicant and no correspondence shall be entertained by SBI in this regard.

(v) The applicant should be bona-fide resourceful and well experienced contractor/firm and should not have been disqualified/ debarred/ terminated on account of poor or unsatisfactory performance/ blacklisted from any Government, Semigovernment, PSU, Banks or any other organizations including any of the Offices/Branch of State Bank of India during last 7 years as on 31.03.2023.

(vi) The application of disqualified/ debarred/ blacklisted/ terminated agency/ contractor/ vendor on account of poor or unsatisfactory performance shall be summarily rejected and if such cases are found at a later stage, their empanelment will be cancelled. (vii) SBI may choose to carry out physical inspection of works mentioned by the applicants in their application forms, in addition to calling for confidential reports from the respective employer/client/department to ascertain their capability and quality of works. The applicant shall agree and authorize SBI to obtain the confidential report from the clients of the applicant contractors, to obtain credit opinion from the Bankers and to verify the work executed by the contractors.

(viii) <u>The validity of the panel is 3 years</u> from the date of approval by the Bank. However, the performance of all the empaneled contractors shall be reviewed periodically and the contractors with unsatisfactory performance will be removed from the panel without notice and no correspondence will be entertained in this regard. Such contractors shall not be eligible for next one empanelment process to be done by SBI. Thereafter, if they wish they can apply afresh for empanelment.

(ix) The panel of contractors will be valid <u>for the entire Chennai Circle (Tamil Na-</u> du & Pondicherry) and contractors will be entitled to participate anywhere within these areas.

(x) Empanelment procedure is to create a panel of Contractors for undertaking composite works. Mere empaneling does not guarantee any work allotment to the panel contractors. The work allotment is done through an online tendering process for its projects among the panel contractors. Therefore, the contractor will have to submit valid e-mail ID, Mobile no. and shall possess a valid Digital Certificate(suitable for online tendering) to enable the firms for participation in the online procurement/e-tendering.

(xi) The contractors should be equipped with necessary infrastructure, machinery and tools, labour strength, etc. to carry our the composite works

(xii) Canvassing in any form including bringing influence from any person /agency /Officials /authorities shall lead to disqualification of the applicant.

(xiii) Bank reserves the right to accept or reject any or all the applications without assigning any reason thereof and no correspondence will be entertained in this regard.

(xiv) Any amendments/ corrigendum for empanelment of contractors/ vendors shall be published in Bank's website only. Therefore, applicants are requested to visit Bank's website regarding modifications/ corrigendum issued till the last day for the submission of the applications
