Sr. No.	Query Received	Bank's Reply
1	Fins of Building to be repaired or Not	The Fins around the building shall be demolished, if it is not a structural member.
2	Is there any provision of ASD?	Bidder has to submit ASD as per RFP Clause no 4 of NIT.
3	Structural audit certificate of the work	The work is to be executed as per RFP specification & as directed by Bank's structural consultant and in tune with IIT Powai structural audit report. The work is to be executed of highest standard as per RFP specifications, terms and

		conditions, so as to meet IIT audit requirement. Any defect pointed out during and after the work has to be rectified/ redone by contractor at his own risk and cost.
4	Common Points mentioned in PRICE bid	The common points mentioned in the preamble are mandatory and has to be complied with for the safe execution of work.
5	Increase time of Work completion?	Completion period of project will remain same as per RFP clause No 2 of NIT.
6	Exemption for EMD for MSME	As per RFP, there is no exemption for EMD. Contractor has to be submit EMD as per RFP clause no. 3 of NIT
7	Is it require to submit hard copy of documents?	There is no requirement to submit hard copy of the documents. Only digitally signed soft copy of the documents to be uploaded as mentioned in clause 14 at page no 16.
8	Physical presence of vendor in pre-bid meeting should be mandatory to be participate in tender process.	As per RFP, all vendor/contractor were invited to participate in pre-bid meeting. Although, it was their decision to attend or not.
9	Specialized structural repair work	The structural repair work required in the buildings are to be carried out by the experienced applicators of respective OEM's of structural repair materials.
